Description

Provides functions to simulate data sets from hierarchical ecological models, including all the simulations described by Marc Kéry and Andy Royle in the two-volume publication, *Applied Hierarchical Modeling in Ecology: analysis of distribution, abundance and species richness in R and BUGS*, Academic Press (Vol 1, 2016; Vol 2, 2021), plus new models developed after publication of the books.

It also has all the utility functions and data sets needed to replicate the analyses shown in the books.

Forest and water coverage (in percent area) was computed using the 1992-97 landcover dataset of the Swiss Federal Statistical Office (http://www.bfs.admin.ch). Median elevation (in meters) was computed using a median aggregation of the digital elevation model of the Swiss Federal Statistical Office.

x and y are the coordinates of the center of each 1km2 pixel.

The coordinate reference system is intentionally not specified.

These data can only be used for non-profit projects. Otherwise, written permission must be obtained from the Swiss Federal Statistical Office.

Color Ramps

Description

These create vectors of n contiguous colors for use in image and raster plots. They are similar to heat.colors or terrain.colors but with extra arguments to give greater control of colors. Currently included ramps are:

- * sequential yellow-orange-red
- * sequential light to dark green
- * sequential light to dark gray
- * diverging blue-yellow-red
- * diverging green-brown

Sequential ramps go from light to dark, diverging ramps from dark through light to dark. All these ramps are color-blind safe and based on color palettes from https://colorbrewer2.org/ by Cynthia Brewer and colleagues.

Count data from the Swiss Breeding Bird Survey MHB for crested tits from 1999 to 2015

Description

The Swiss breeding bird survey ("Monitoring Häufige Brutvögel" MHB) has monitored the populations of approximately 150 common species since 1999. The MHB sample consists of 267 1-km squares that are laid out as a grid across Switzerland. Fieldwork is conducted by about 200 skilled birdwatchers annually, most of them volunteers. Avian populations are monitored using a simplified territory mapping protocol (also called spot-mapping West of the Atlantic), where each square is surveyed up to three times during the breeding season (only twice above the tree line around 2000 m elevation). Surveys are conducted along a transect that does not change over the years and is 4-6 kms in length on average.

The data frame crestedTit has the data for Crested Tits *Parus cristatus* from 1999 to 2015. There are some missing values: see Details.

Format

crestedTit is a data frame with 267 rows and 131 columns:

- **coordx, coordy** the x and y coordinates of the center of the quadrat; the coordinate reference system intentionally not specified.
- elev the mean elevation of the quadrat, in meters.

forest percentage forest cover

- **nsurveys** the number of replicate surveys *planned* in the quadrat; above the tree-line 2, otherwise 3.
- 1999 to 2016 total number of territories observed for the year.
- **date991 to date163** Julian date of the survey, 1 = 1st January; the first 2 digits in the column name indicate the year and the 3rd digit the survey.
- **dur991 to dur163** duration of the survey, in minutes; the first 2 digits in the column name indicate the year and the 3rd digit the survey.

Details

Missing values in the date array indicate that the corresponding survey was not carried out.

On 26 occasions when surveys were carried out, the duration was not recorded, resulting in additional NAs in the dur array.

A new method for recording breeding territories was introduced in 2004, but the old protocol was in use at some sites until 2013. Surveys with the old protocol have the counts shown as NA in the count array.

Description

Generates data for distance sampling from spatially-replicated point transects, with density dependent on a spatially correlated habitat covariate. For each point count, the procedure is:

1. Simulate the habitat covariate over a grid of pixels covering a square.

2. Distribute the population of individuals over the square with probability of location in a pixel related to the covariate.

3. Decide which individuals are detected using a distance sampling model with an observer at the center of the square, with a half normal detection function. (Note that individuals outside the circle of radius B can be detected.)

The locations and detection status of individuals at all sites are collated and returned, except for individuals at sites when none are detected.

Details

Function simulates data from repeated sampling of a metacommunity (or spatially structured community) according to the model of Dorazio & Royle (JASA, 2005) for type = "det/nondet" (this is the default) or under the model of Yamaura et al. (2012) for type = "counts".

Description

The function generates a population represented as a point pattern in a heterogeneous landscape and simulates data from two different sources: (1) opportunistic presence-only data, and (2) replicate counts or detection/nondetection data in randomly-placed quadrats. This is the scenario for the integrated models described by Dorazio (2014) and Koshkina et al. (2017). The former assumes counts as data source (2) while the latter assume detection/nondetection data.

A Poisson point pattern (PPP) with intensity a function of a covariate X and intercept and coefficient beta is simulated on a discrete (pixel-based) approximation of a continuous landscape.

This PPP is first thinned with a pixel-wise thinning probability controlled by a covariate W and coefficients alpha, and second, with a landscape-wise random drop-out process to produce a first data set of presence-only kind.

A second data set is simulated by imagining replicated counts conducted in randomly-selected quadrats within the landscape. Detection of individuals is imperfect, with probability of detection controlled by the covariate W and coefficients gamma. These counts can be quantized to detection/nondetection data for use in a model as in Koshkina et al. (2017).

For simDataDK1 animals are limited to one individual per pixel; this is not the case for simDataDK.

Description

Function to simulate detection/nondetection data under a general dynamic community (= dynamic, multi-species site-occupancy) model, including:

* annual variation in the probabilities of patch persistence, colonization and detection is specified by the bounds of a uniform distribution.

* species heterogeneity around the community means is specified by the SD of a normal distribution and expressed on the logit scale

* one covariate is allowed per parameter (site covariate for psi1, site-year covariate for phi and gamma and site-year-rep covariate for p). Each covariate is allowed to differ among species again according to a logit-normal model of heterogeneity.

* additional detection heterogeneity at the site- or the occasion level, with the possibility of a temporal trend in this heterogeneity over years. E.g., an annual trend in detection heterogeneity at the site or the occasion level is specified by the value in the first and the last year. simDynoccSpatial Simulate data under a dynamic occupancy model with spatial autocorrelation

Description

Function to simulate detection/nondetection data under a general dynamic site-occupancy model with autocorrelation, including:

* Annual variation in the probabilities of patch persistence, colonization and detection is specified by the bounds of a uniform distribution.

* One covariate is allowed to affect a parameter: a site covariate for psi1, site-by-year covariates for phi and gamma, and an observational covariate for p. Covariates are generated internally from uniform(-2, 2) distributions.

* Additional heterogeneity among sites in persistence and colonization or both.

* Additional detection heterogeneity at the site or survey level, with the possibility of a temporal trend in this heterogeneity over the years. E.g., an annual trend in detection heterogeneity at the site or the survey level is specified by the first and second value, which correspond to the heterogeneity in the first and the last year. Hence, trend.sd.site = c(0, 1) will result in a linear trend in the magnitude of site heterogeneity in detection from 0 in the first year to 1 in the last year.

* A single, spatially structured covariate for habitat suitability may affect all parameters via coefficient beta.XAC; for a biologically reasonable way, choose coefficients with the same sign for all 4 (mediated by underlying density). That spatial covariate is simulated as a Gaussian random field with negative exponential correlation function with 'range parameter' theta.XAC. * Autologistic effects (beta.Xautolog) in persistence and colonization probability can be chosen, which fits a logistic regression of these parameters on the proportion of occupied neighboring cells (in a queen's or 2nd order neighborhood) during the previous time step.

* Additional detection heterogeneity can be introduced at the site- or the individual survey level, with the possibility of a temporal trend in this heterogeneity. For instance, an annual trend in detection heterogeneity at the site or the survey level is specified by the value in the first and the last year. Hence, trend.sd.site = c(0, 1) will result in a linear trend in the magnitude of site heterogeneity in detection from 0 in the first year to 1 in the last year.

Previous versions used **RandomFields**, but that is not currently available on CRAN. **fields** is now used instead, but it cannot deal with large values of side and theta.XAC. Simulate data under hierarchical distance sampling point transect protocol

Description

The function simulates hierarchical distance sampling (HDS) data under a point transect protocol. At each site, it works with a circle of radius B.

The state process is simulated by first drawing a covariate value, "habitat", for each site from a Normal(0, 1) distribution. This is used in a log-linear regression with arguments mean.density and beta.density to calculate the expected density of animals per hectare. The expected number of animals in the circle is calculated from the area of the circle and the density, and numbers are drawn from a Poisson distribution for each site.

Animals are assumed to be distributed randomly over the circle, and distances from the point are generated.

A detection covariate, "wind", for each site is drawn from a Uniform(-2, 2) distribution. This is used in a log-linear regression with arguments mean.sigma and beta.sigma to calculate the scale parameter, sigma, of the half-normal detection function. Detections are simulated as Bernoulli trials with probability of success decreasing with distance from the point.

This is a simplified (and faster) version of the function simHDS with type="point", but works with densities and with measurements in hectares and meters.

Description

A general function for simulating hierarchical distance sampling (HDS) data combined with a timeremoval (with 3 removal periods) or double-observer protocol, either for a line or a point transect protocol and with method = "removal" or method = "double". Also produces plots of the output.

At each site, it works with a strip of width B*2 (for line transects) or a circle of radius B (for point transects).

The state process is simulated by first drawing a covariate value, "habitat", for each site from a Normal(0, 1) distribution. This is used in a log-linear regression with arguments beta0 and beta1 to calculate the expected number of groups in each strip or circle. Group size is simulated by first drawing from a Poisson distribution with parameter lambda.group then adding 1.

For line transects, the distance from the line is drawn from a Uniform(0, B) distribution. For point transects, the distance from the point is simulated from B*sqrt(Uniform(0,1)), which ensures a uniform distribution over the circle.

The group size is used in a log-linear regression with arguments alpha0 and alpha1 to calculate the scale parameter, sigma, of the half-normal detection function. Detections are simulated according to the selected protocol.

To recreate the data sets used in the book with R 3.6.0 or later, include sample.kind="Rounding" in the call to set.seed. This should only be used for reproduction of old results.

Description

Generates hierarchical distance sampling data, point count data, and occupancy (detection/nondetection) data for an integrated distance sampling (IDS) model with shared density and availability processes, but possibly different detection/perceptability processes (i.e., different detection functions).

The function calls simHDSpoint to generate hierarchical distance sampling (HDS) data under a point transect protocol with a half-normal detection function. Density is modeled as a log-linear regression on a "habitat" covariate, with coefficients mean.density and beta.density.

Point count and occupancy data are also generated by calls to simHDSpoint, assuming that the underlying detection process involves reduced probability of detection with distance from the observer. The distances from the observer are discarded, and only the counts (for PC data) or species detection information (for occupancy) retained.

Availability is modeled according to Sólymos et al. (2013), where the probability of availability depends on the duration of the observation.

Details

Data are simulated at the level of each individual and individual-specific detection heterogeneity can be included. As a side-effect, individual-specific detection histories are generated and hence, data are also be simulated under the corresponding multinomial N-mixture model.

Broadly, the function can generate data under this most general model:

'Suitability' (zero-inflation) ~ cov1 + cov2 + cov3

Abundance ~ offset + cov2 + cov3 + cov4 + overdispersion

Detection ~ cov3 + cov5 + cov6 + survey.covariate + log(N+1) + eps.site + eps.visit + eps.survey + eps.individual

Overdispersion in abundance is modeled either as a Poisson-log-normal with a normal random site effect in lambda or with a Negative binomial with mean lambda and a 'size', or dispersion, parameter. Variable site areas can be specified to affect abundance as in an offset.

Abundance can be zero-inflated (this is the 'suitability' model). Note that the zero-inflation parameter is called theta here (in unmarked it is called psi). mean.phi is the probability that a site is suitable (i.e., 1 minus the expected proportion of sites with structural zero abundance.

Site covariate 2 can affect both suitability and abundance, while covariate 3 may affect all three levels. Hence, the function permits to simulate the case where a single site covariate affects different levels in the process (e.g., abundance and detection) in opposing directions (as for instance in Kéry, 2008)

Density-dependent detection can be modeled as a logistic-linear effect of local abundance (centered and log(x+1) transformed). Overdispersion in detection is modeled via normal random effects (the eps terms above) specific to sites, visits, surveys or individuals.

Effects of covariates and random-effects factors are modeled as additive on the link scale (log for abundance and logit for suitability and detection).

Data may be generated under one specific open-population model when argument 'open.N' is set to TRUE.

Simulate replicated counts under a spatial, static binomial N-mixture model

Description

Simulates replicated counts under a spatial, static binomial N-mixture model for a semi-realistic landscape in a square of 50x50 km in the Bernese Oberland around Interlaken, Switzerland. Unit of the data simulation is a 1km2 quadrat, hence, there are 2500 units. It uses the data set BerneseOberland, which has covariates for elevation and forest cover.

For abundance, the function allows you to specify a quadratic effect of elevation. Then, a Gaussian spatial random field (s) with negative exponential correlation function is simulated using simExpCorrRF; you can set the variance and the range (scale) parameter theta. Basically, the larger the value of theta.RF, the bigger are the 'islands' simulated in the random field. The abundance in each quadrat (i) is built up via the following linear predictor:

lambda[i] <- exp(beta0 + beta[1] * elev[i] + beta[2] * elev[i]^2 + s[i])
N[i] ~ Poisson(lambda[i])</pre>

Replicated counts are simulated as usual under a binomial observation model, and detection probability is allowed to vary by one site and one observational covariate: respectively quadrat forest cover (in the BerneseOberland data set), and wind-speed, which is invented data. Counts at each site (i) and for each occasion (j) are then produced according to the following model:

p[i,j] <- plogis(alpha0 + alpha[1] * forest[i] + alpha[2] * wind[i,j])
C[i,j] ~ Binomial(N[i], p[i,j])</pre>

Finally, we assume that only a subset of the 2500 quadrats is surveyed. Hence, we allow you to choose the number of quadrats that are surveyed and these will then be randomly placed into the landscape. We then assume that counts will only be available for these surveyed quadrats, i.e., counts from all non-surveyed quadrats will be NA.

To recreate the data sets used in the book with R 3.6.0 or later, call RNGversion="3.5.3" before the call to simNmixSpatial. This should only be used for reproduction of old results.

simOccSpatial Simulate replicated detection/nondetection data under a spatial, static occupancy model

Description

Simulates replicated detection/nondetection data under a spatial, static occupancy model for a semirealistic landscape in a square of 50x50 km in the Bernese Oberland around Interlaken, Switzerland. Unit of the data simulation is a 1km2 quadrat, hence, there are 2500 units. It uses the data set BerneseOberland, which has covariates for elevation and forest cover.

For occupancy, the function allows you to specify a quadratic effect of elevation. Then, a Gaussian spatial random field (s) with negative exponential correlation function is simulated using simExpCorrRF; you can set the variance and the range (scale) parameter theta. Basically, the larger the value of theta.RF, the bigger are the 'islands' simulated in the random field. The abundance in each quadrat (i) is built up via the following linear predictor:

Replicated detection/nondetection data are simulated as usual under a Bernoulli observation model, and detection probability is allowed to vary by one site and one observational covariate: respectively quadrat forest cover (in the BerneseOberland data set), and wind-speed, which is invented data. Counts at each site (i) and for each occasion (j) are then produced according to the following model:

Finally, we assume that only a subset of the 2500 quadrats is surveyed. Hence, we allow you to choose the number of quadrats that are surveyed and these will then be randomly placed into the landscape. We then assume that counts will only be available for these surveyed quadrats, i.e., detection/non-detection data from all non-surveyed quadrats will be replaced with NA.

To recreate the data sets used in the book with R 3.6.0 or later, call RNGversion="3.5.3" before the call to simOccSpatial. This should only be used for reproduction of old results.

Description

The function simulates a spatial point pattern in a heterogeneous landscape simulated on a square landscape. The study area ('core') is simulated inside the larger landscape that includes a buffer. The size of the core is defined by the lscape.size minus twice the buffer.

There is one habitat covariate X that affects the intensity of the points. X is spatially structured with negative-exponential spatial autocorrelation; the parameters of the field can be chosen to create large 'islands' of similar values or no 'islands' at all, in which case the field is spatially unstructured.

The intensity of STATIC points (e.g. animal activity centers) may be inhomogeneous and affected by the coefficient beta, which is the log-linear effect of X.

To recreate the data sets used in the book with R 3.6.0 or later, include sample.kind="Rounding" in the call to set.seed. This should only be used for reproduction of old results.

Previous versions used **RandomFields**, but that is not currently available on CRAN. **fields** is now used, but it cannot deal with large values of lscape.size and theta.X. Data from the Swiss Breeding Bird Survey for 6 species of tits

Description

The Swiss breeding bird survey ("Monitoring Häufige Brutvögel" MHB) has monitored the populations of approximately 150 common species since 1999. The MHB sample consists of 267 1-km squares that are laid out as a grid across Switzerland. Fieldwork is conducted by about 200 skilled birdwatchers annually, most of them volunteers. Avian populations are monitored using a simplified territory mapping protocol (also called spot-mapping West of the Atlantic), where each square is surveyed up to three times during the breeding season (only twice above the tree line around 2000 m elevation). Surveys are conducted along a transect that does not change over the years and is 4-6 kms in length on average.

The list SwissTits has the data for six species of tits from 2004 to 2013. There are some missing values: see Details.

Description

Mizel et al. (2018) describe the data on American Tree Sparrows (*Spizella arborea*) that were collected in May and June 2016 at Noatak National Preserve, Alaska. The study area was a 10.8 x 9.6 km rectangle divided up into 288 plots of 600 m x 600 m, of which 150 had some coverage by a transect running through them. Routes were usually chosen to intersect the centroid of the cell and deflected by 0 or 90 degrees when required to move into an adjacent cell. In some cases, a transect was shifted to avoid terrain features. Distance measurements were truncated at 250m from the observer. Each visited plot was surveyed an average of three times (max = 5). Each plot was gridded to a 30-m resolution and spatial attributes were associated with each of these pixels. This resulted in an average of 328 pixels per plot within the buffered transect. Bird locations were assigned to the nearest pixel centroid.

Data from the UK Butterfly Monitoring Scheme (UKBMS) for the Marbled White butterfly (*Melanargia galathea*), a fairly widespread species that flies in a single generation per year in the UK.

Most survey sites are chosen opportunistically and represent fixed transects of variable and often unknown length, which are walked between two and 26 times per year starting in early April. Butterflies are counted within an imaginary 5m x 5m 'moving box' along the transects (i.e., according to a Pollard walk protocol).

We restrict the data to sites where the marbled white was ever recorded, the years 1991–2015 and those 80 sites where counts took place in at least 20 of these 25 years.

Where species identifications (from photos, recorded calls, etc) is doubtful, it is sometimes feasible for a subset of the data to be validated by experts. Chambert et al (2017) used simulations to investigate the effectiveness of such partial validation. Where a data set with false positives has been simulated and the true status is known, valid_data compares a subset with truth and returns the number of detections checked per site and the number checked and found to be valid. The function attempts to validate equal numbers of detections at each site (not equal proportions) subject to the actual number of detections and the total number to be validated; if the number of detections is small, all will be validated, otherwise a random sample is used; see Examples.

These data are for the Yellow Wagtail (*Motacilla flava*).
