DLSEMs are Markovian structural causal models where each factor of the joint probability distribution is a distributed-lag linear regression with constrained lag shapes (Magrini, 2018 <doi:10.2478 bile-2018-0012="">; Magrini et al., 2019 <doi:10.1007 s11135-019-00855-z="">). DLSEMs account for temporal delays in the dependence relationships among the variables through a single parameter per covariate, thus allowing to perform dynamic causal inference in a feasible fashion. Endpoint-constrained quadratic, quadratic decreasing, linearly decreasing and gamma lag shapes are available.</doi:10.1007></doi:10.2478>

### **Description**

Inference functionalities for distributed-lag linear structural equation models (DLSEMs). DLSEMs are Markovian structural causal models where each factor of the joint probability distribution is a distributed-lag linear regression with constrained lag shapes (Magrini, 2018; Magrini et. al, 2019; Magrini, 2020). DLSEMs account for temporal delays in the dependence relationships among the variables through a single parameter per covariate, thus allowing to perform dynamic causal inference in a feasible fashion. Endpoint-constrained quadratic ('ecq'), quadratic decreasing ('qd'), linearly decreasing ('ld') and gamma ('gam') lag shapes are available. The main functions of the package are:

- dlsem, to perform parameter estimation;
- causalEff, to compute all the pathwise causal lag shapes and the overall one connecting two or more variables;
- lagPlot, to display a pathwise or an overall causal lag shape.

Assessment of dynamic causal effects

### **Description**

All the pathwise causal lag shapes and the overall one connecting two or more variables are computed.

use.ns	A logical value indicating whether edges without statistically significant causal effect (at level conf) should be considered or not. If FALSE (the default), they will be ignored.

#### **Details**

A pathwise causal lag shape is the set of causal effects associated to a path at different time lags. An overall causal lag shape is the set of overall causal effects of a variable on another one at different time lags.

Note that, due to the properties of the multiple linear regression model, causal effects are net of the influence of the group factor and exogenous variables.

#### Value

A list containing several matrices including point estimates, standard errors and asymptotic confidence intervals (at level conf) for all the pathwise causal lag shapes and the overall one connecting the starting variables to the ending variable.

#### Note

Value NULL is returned if one of the following occurs: (i) no significant path at confidence level conf exists connecting the starting variables to the ending variable; (ii) the requested path does not exist or is not significant at confidence level conf. Note that the edges between the starting variables and their respective parents are deleted as a consequence of intervention. See Magrini (2018) for technical details on causal inference in distributed-lag linear structural equation models.

### Description

Several competing distributed-lag linear structural equation models are compared based on information criteria.

### Usage

compareModels(x)

### **Arguments**

x A list of 2 or more objects of class dlsem estimated on the same data.

#### Value

A data.frame with one record for each model in x on the following quantities: log-likelihood, number of parameters, Akaike Information Criterion (AIC),

Bayesian Information criterion (BIC).

#### Note

In order to keep the sample size constant, only the non-missing residuals across all the models are considered (see Magrini, 2020, for details).

Parameter estimation

### **Description**

Parameter estimation is performed for a distributed-lag linear structural equation model. A single group factor may be taken into account.

#### Usage

### Arguments

model.code

A list of objects of class formula, each describing a single regression model.

See Details.

group

The name of the group factor (optional). If NULL, no groups are considered.

time

The name of the variable indicating the date time (optional). This variable must be either a numeric identificative or a date in format '%Y/%m/%d', '%d/%m/%Y', or '%Y-%m-%d'. If time is NULL and group is not NULL, data are assumed to be temporally ordered within each group. If both time and group are NULL, data

are assumed to be temporally ordered.

exogenous

The name of exogenous variables (optional). Exogenous variables may be either quantitative or qualitative and must not appear in the model code.

data

An object of class data. frame containing data.

hac

Logical. If TRUE, heteroskedasticity and autocorrelation consistent (HAC) estimation of standard errors by Newey & West (1978) is applied, otherwise OLS standard errors are used. Default is TRUE.

gamma.by

A real number between 0 and 1 defining the resolution of the grid for the adaptation of gamma lag shapes. Adaptation is more precise with values near 0, but it will also take more time. Default is 0.05.

global.control A list containing global options for the estimation. The list may consist of any number of components among the following:

- adapt: a logical value indicating whether adaptation of lag shapes should be performed for all regression models. Default is FALSE;
- min.gestation: the minimum gestation lag for all covariates. If not provided, it is assumed to be equal to 0. Ignored for a gamma lag shape or if adapt=FALSE;
- max.gestation: the maximum gestation lag for all covariates. If not provided, it is assumed to be equal to max.lead (see below). Ignored for a gamma lag shape or if adapt=FALSE;
- max.lead: the maximum lead lag for all covariates. If not provided, it is computed accordingly to the sample size. Ignored if adapt=FALSE. Note that the lead lag for a gamma lag shape is determined numerically;
- min.width: the minimum lag width for all covariates. It cannot be greater than max.lead. If not provided, it is assumed to be 0. Ignored for a gamma lag shape or if adapt=FALSE;
- sign: the sign of parameter  $\theta_i$  (either '+' for positive or '-' for negative) for all covariates. If not provided, adaptation will disregard the sign of parameter  $\theta_i$ . Ignored if adapt=FALSE.

local.control

A list containing variable-specific options for the estimation. These options prevail on the ones contained in global.control. See Details.

log

Logical or a vector of characters. If a vector of characters is provided, logarithmic transformation is applied to strictly positive quantitative variables with name matching those characters. If TRUE, logarithmic transformation is applied to all strictly positive quantitative variables. Default is FALSE.

diff.options

A list containing options for differencing. The list may consist of any number of components among the following:

- test: the unit root test to apply, that may be either "kpss" for KPSS test or "adf" for ADF test (see unirootTest). If NULL (the default), the choice is for the KPSS test if the number of periods is less than 100, otherwise the ADF test is used.
- maxdiff: the maximum differencing order to apply. If maxdiff=0, differencing will not be applied. Default is 3;
- ndiff: the order of differencing to apply (without performing unit root test). If ndiff=NULL, differencing will be applied according to unit root test. Default is NULL.

Differencing is applied to remove unit roots, thus avoiding spurious regression (Granger \& Newbold, 1974). The same order of differencing will be applied to all quantitative variables.

imput.options

A list containing options for the imputation of missing values through the Expectation-Maximization algorithm (Dempster et al., 1977). The list may consist of any number of components among the following:

- tol: the tolerance threshold. Default is 0.0001;
- maxiter: the maximum number of iterations. Default is 500. If maxiter=0, imputation will not be performed;
- maxlag: The maximum autoregressive order to consider in the imputation. Default is 3.
- no. input: the name of variables to which imputation should not be applied.

Only missing values of quantitative variables will be imputed. Qualitative variables cannot contain missing values.

quiet

Logical. If TRUE, messages on the estimation progress are suppressed. Deafult is FALSE.

#### **Details**

Each regression model in a distributed-lag linear structural equation model has the form:

$$y_t = \beta_0 + \sum_{i=1}^{p} \sum_{l=0}^{L_i} \beta_{i,l} \ x_{i,t-l} + \epsilon_t$$

where  $y_t$  is the value of the response variable at time t,  $x_{i,t-l}$  is the value of the i-th covariate at l time lags before t, and  $\epsilon_t$  is the random error at time t uncorrelated with the covariates and with  $\epsilon_{t-1}$ . The set  $(\beta_{i,0}, \beta_{i,1}, \ldots, \beta_{i,L_i})$  is the lag shape of the i-th covariate.

Currently available lag shapes are the endpoint-constrained quadratic lag shape:

$$\beta_{i,l} = \theta_i \left[ -\frac{4}{(b_i - a_i + 2)^2} l^2 + \frac{4(a_i + b_i)}{(b_i - a_i + 2)^2} l - \frac{4(a_i - 1)(b_i + 1)}{(b_i - a_i + 2)^2} \right] \qquad a_i \le l \le b_i$$

(otherwise,  $\beta_{i,l} = 0$ ); the quadratic decreasing lag shape:

$$\beta_{i,l} = \theta_i \frac{l^2 - 2(b_i + 1)l + (b_i + 1)^2}{(b_i - a_i + 1)^2} \qquad a_i \le l \le b_i$$

(otherwise,  $\beta_{i,l} = 0$ ); the linearly decreasing lag shape:

$$\beta_{i,l} = \theta_i \frac{b_i + 1 - l}{b_i + 1 - a_i} \qquad a_i \le l \le b_i$$

(otherwise,  $\beta_{i,l} = 0$ ); the gamma lag shape:

$$\beta_{i,l} = \theta_i (l+1)^{\frac{a_i}{1-a_i}} b_i^l \left[ \left( \frac{a_i}{(a_i-1)\log(b_i)} \right)^{\frac{a_i}{1-a_i}} b_i^{\frac{a_i}{(a_i-1)\log(b_i)}-1} \right]^{-1}$$

$$0 < a_i < 1 \qquad 0 < b_i < 1$$

See Magrini (2020) for details on these constrained lag shapes.

Formulas cannot contain neither qualitative variables or interaction terms (no ':' or '\*' symbols), nor functions excepting the following operators for the specification of lag shapes:

- ecq: quadratic (2nd order polynomial) lag shape with endpoint constraints;
- qd: quadratic (2nd order polynomial) decreasing lag shape;
- 1d: linearly decreasing lag shape;
- gam: gamma lag shape.

Each operator must have the following three arguments (provided within brackets and separated by commas):

- 1. the name of the covariate to which the lag is applied;
- 2. parameter  $a_i$ ;
- 3. parameter  $b_i$ ;
- 4. the group factor (optional). If not provided and argument group is not NULL, this is found automatically.

The formula of regression models with no endogenous covariates may be omitted from argument model.code. The group factor and exogenous variables must not appear in any formula.

Argument local.control must be a named list containing one or more among the following components:

- adapt: a named vector of logical values, where each component must have the name of one endogenous variable and indicate whether adaptation of lag shapes should be performed for the regression model of that variable.
- min.gestation: a named list. Each component of the list must have the name of one endogenous variable and be a named vector. Each component of the named vector must have the name of one covariate in the regression model of the endogenous variable above and include the minimum gestation lag for its lag shape.
- max.gestation: the same as min.gestation, with the exception that the named vector must include the maximum gestation lag.
- max.lead: the same as min.gestation, with the exception that the named vector must include the maximum lead lag.
- min.width: the same as min.gestation, with the exception that the named vector must include the minimum lag width.
- sign: the same as min.gestation, with the exception that the named vector must include the lag sign (either '+' for positive or '-' for negative). Local control options have no default values, and global ones are applied in their absence. If some local control options conflict with global ones, only the former are applied.

#### Value

An object of class dlsem, with the following components:

estimate A list of objects of class 1m, one for each regression model.

model.code The model code, eventually after adaptation of the lag shapes.

call A list containing the call for each regression, eventually after adaptation of lag

shapes.

lag.par A list containing the parameters of the lag shapes for each regression, eventually

after adaptation.

exogenous The names of exogenous variables.

group The name of the group factor. NULL is returned if group=NULL.

The name of the variable indicating the date time. NULL is returned if time=NULL.

The name of the variables to which logarithmic transformation was applied.

ndiff The order of differencing applied to the time series.

data The data after eventual logarithmic transformation and differencing, which were

actually used to estimate the model.

data.orig The dataset provided to argument data.

fitted The fitted values. residuals The residuals.

autocorr The estimated order of the residual auto-correlation for each regression model.

Logical indicating whether HAC estimation of standard errors is applied.

adaptation Variable-specific options used for the adaptation of lag shapes.

S3 methods available for class dlsem are:

print provides essential information on the model.

summary shows summaries of estimation.

plot displays the directed acyclic graph (DAG) of the model including only the en-

dogenous variables. Option conf controls the confidence level (default is 0.95),

while option style controls the style of the plot:

• style=2 (the default): each edge is coloured with respect to the sign of the estimated causal effect (green: positive, red: negative, light grey: not statistically significant);

• style=1: edges with statistically significant causal effect are shown in black, otherwise they are shown in light grey;

• style=0: all edges are shown in black disregarding statistical significance of causal effects.

nobs returns the number of observations for each regression model.

npar returns the number of parameters for each regression model.

coef returns the estimates of scale parameters for each regression model.

confint returns the confidence intervals of scale parameters for each regression model.

Argument level controls the confidence level (default is 0.95).

vcov returns the covariance matrix of estimates for each regression model.

logLik returns the log-likelihood for each regression model.

fitted returns fitted values.
residuals returns residuals.

predict returns predicted values. Optionally, a data frame from which to predict may be

provided to argument newdata.

If the group factor is specified, p-values of each group are combined using the method proposed by Demetrescu (2006).
